

**A RESOLUTION AUTHORIZING A PROFESSIONAL SERVICES
AGREEMENT WITH DAVID P. LONSKI OF THE FIRM
SHAMY, SHIPERS & LONSKI, PC
TO SERVE AS MUNICIPAL PROSECUTOR**

WHEREAS, the Township of North Brunswick has a need to acquire professional services for Municipal Prosecutor under a fair and open contract process pursuant to the provisions of N.J.S.A. 19:44A-20.1 et seq.; and

WHEREAS, on October 18, 2010 the Township Council of the Township of North Brunswick approved Resolution 292-10.10 authorizing the issuance of Requests for Qualifications for professional services to perform the duties of Municipal Prosecutor in the North Brunswick Municipal Court; and

WHEREAS, the Purchasing Agent received, and the Deputy Municipal Clerk witnessed, the receipt of Requests for Qualifications for said professional services on November 17, 2010; and

WHEREAS, the Purchasing Agent has determined the anticipated aggregate value of professional services will exceed \$17,500.00; and

WHEREAS, David P. Lonski of the firm Shamy, Shippers & Lonski, PC submitted a proposal on November 17, 2010 in response to QUA10004 to provide professional services as Municipal Prosecutor; and

WHEREAS, Administration, Purchasing, and Legal Counsel have reviewed the Qualifications for professional services of David P. Lonski of the firm Shamy, Shippers & Lonski, PC and determined him responsive in all respects and qualified for the position; and

WHEREAS, it is in the best interest of the Township of North Brunswick to enter into an agreement with David P. Lonski of the firm Shamy, Shippers & Lonski, PC (251 Livingston Avenue, New Brunswick, NJ 08901) to serve in the position of Municipal Prosecutor for calendar year 2011; and

WHEREAS, compensation for these services shall be paid at a rate of \$275.00 per session for regularly scheduled and special sessions and reimbursable expenses in an amount not to exceed \$35,000.00 for calendar year 2011; and

WHEREAS, the Chief Financial Officer has certified that \$20,000.00 is available for this purpose in account 1-01-20-155-000-982 for services ending June 30, 2011 and the balance of funds shall be certified upon the appropriation of funds in FY 2012.

NOW, THEREFORE, BE IT RESOLVED on this 1st day of January, 2011, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with David P. Lonski of the firm Shamy, Shippers & Lonski, PC to serve as Municipal Prosecutor for calendar year 2011.

BE IT FURTHER RESOLVED notice of this action shall be published in the Home News & Tribune as required by law within 10 (ten) days after its passage.
