

**A RESOLUTION AUTHORIZING AWARD OF CONTRACT BID11001 TO  
LUCAS BROTHERS, INC. FOR THE  
2011 ROAD IMPROVEMENT PROGRAM**

**WHEREAS**, the Department of Community Development is responsible for construction and improvements of Township streets, roads and curbing; and

**WHEREAS**, Michael C. Hritz, the Director for the Department of Community Development, along with the Mayor and Council have reviewed the 2011 plans and have determined it necessary to continue with the 2011 road schedule as part of the Township 15 year road program; and

**WHEREAS**, \$250,000.00 of the project cost will be funded from the 2011 New Jersey Department of Transportation Grant for Omaha Road and \$93,750.00 will be funded from the 2010 New Jersey Department of Transportation Grant for Hermann Road; and

**WHEREAS**, the remaining cost of this project will be funded from existing Capital Ordinances 08-23, 10-23, 09-16, 03-31, 05-16, 06-16, 08-22, 05-17; and

**WHEREAS**, on December 6, 2010 the Township Council of the Township of North Brunswick approved Resolution 321-12.10 authorizing advertisement for receipt of bids for the 2011 Road Improvement Program, BID11001; and

**WHEREAS**, the Municipal Clerk witnessed the receipt of bids on February 3, 2011 and the lowest qualifying bid was submitted by Lucas Brothers, Inc. of 80 Amboy Road, Morganville, NJ 07751 in the amount of \$3,284,142.78 for Items 1 through 150 inclusive; and

**WHEREAS**, Michael C. Hritz, the Director of the Department of Community Development; CME Associates, Engineers for this project; and Decotiis, Fitzpatrick, and Cole, LLP, appointed Municipal Legal Counsel, have reviewed the bid proposals and determined Lucas Brothers, Inc. to be the lowest responsible bidder under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.


**NOW THEREFORE, BE IT RESOLVED**, that the bid submitted by Lucas Brothers, Inc. is hereby accepted.

**BE IT FURTHER RESOLVED**, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and Township Clerk to witness an agreement with Lucas Brothers, Inc. for the 2011 Road Improvement Program, Contract BID11001, in the amount of \$3,284,142.78 for Items 1 through 150 inclusive, subject to approval by the New Jersey Department of Transportation.
