

**A RESOLUTION AUTHORIZING AWARD OF CONTRACT BID11004
TO OTTO ENVIRONMENTAL SYSTEMS LLC FOR
(2,000) 95 GALLON CONTAINERS**

WHEREAS, the Department of Public Works is responsible for the collection of refuse and recycling generated by residents and various approved entities located within the municipality; and

WHEREAS, Glenn Sandor, the Director of Public Works, determined there is a need to purchase 95 gallon roll out containers for the routine replacement of broken containers; and

WHEREAS, on February 7, 2011 the Township Council approved Resolution 77-2.11 authorizing advertisement for receipt of bids for (2,000) 95 gallon roll out containers BID11004; and

WHEREAS, the Deputy Municipal Clerk witnessed the receipt of six bids on March 4, 2011; and

WHEREAS, the lowest bid submitted by IPL Inc. in the amount of \$83,080.00 only listed one exception in their bid but proposed containers that deviated from the specifications on several items including containers that were 8.57% thinner in wall thickness than the current containers used by Public Works; and

WHEREAS, the second bid submitted by Otto Environmental Systems LLC in the amount of \$90,980.00 is the lowest responsible and responsive qualifying bid; and

WHEREAS, funds in the amount of \$75,980.00 are available in FY2010 Recycling Tonnage Grant account G-02-10-290-000-000 and \$15,000.00 are available in FY2011 Recycling Tonnage Grant account G-02-11-290-000-000; and

WHEREAS, Township Attorney Ronald Gordon has reviewed the proposal submitted by Otto Environmental Systems, LLC and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

WHEREAS, the Department of Public Works recommends approval of the bid submitted by Otto Environmental Systems, LLC.

NOW THEREFORE, BE IT RESOLVED, that the bid submitted by Otto Environmental Systems, LLC is hereby accepted.

BE IT FURTHER RESOLVED, Township Council of the Township of North Brunswick does hereby authorize the award of contract BID11004 to Otto Environmental for the purchase of (2,000) 95 gallon roll out containers in the amount of \$90,980.00.
