

**A RESOLUTION AUTHORIZING THE AWARD OF CONTRACT BID12017  
TO VITELLI TRUCKING, INC.  
FOR SNOW REMOVAL SERVICES**

**WHEREAS**, the Department of Public Works Street and Roads Division is responsible for providing snow removal services from public streets and access ways; and

**WHEREAS**, the current agreement for snow removal services expired November 2012 and the Department of Public Works Director determined there was a need to have supplemental resources available due to the unpredictability of snow events; and

**WHEREAS**, funding for said services will be made available from FY2013 Streets and Roads OE and subsequent fiscal years contingent upon funding availability; and

**WHEREAS**, on July 2, 2012 Resolution 216-7.12 authorized the advertisement for receipt of bids for snow removal services- BID12017; and

**WHEREAS**, a bid opening was held on August 9, 2012 and no bids were received; and

**WHEREAS**, on September 4, 2012 Resolution 261-9.12 authorized the re-advertisement for receipt of bids; and

**WHEREAS**, a bid opening was held on September 29, 2012 and no bids were received; and

**WHEREAS**, pursuant to N.J.S.A. 40A11:5(3) when a bid has been formally advertised on two occasions and no qualified vendor has responded, a contract may be negotiated; and

**WHEREAS**, in October 2012, the Director of Public Works met with Vitelli Trucking, Inc. who has provided snow removal services to the Township for several years; and

**WHEREAS**, in October 2012, the Director of Public Works recommends approval of a contract with Vitelli Trucking, Inc. which includes negotiated terms and conditions; and

**WHEREAS**, the three year contract with Vitelli Trucking, Inc. shall commence on December 1, 2012 and end November 30, 2015 and includes an option for two additional one-year terms.


**NOW THEREFORE, BE IT RESOLVED**, that the negotiated contract with Vitelli Trucking, Inc is hereby accepted.


**BE IT FURTHER RESOLVED**, the Township Council for the Township of North Brunswick does hereby authorize the Mayor to execute and and Township Clerk to witness a three year agreement, not including the option for two additional one-year terms, with Vitelli Trucking, Inc. for Snow Removal Services in an amount not to exceed One Hundred Fifty Thousand Dollars (\$150,000.00).
