

**A RESOLUTION AUTHORIZING AWARD OF CONTRACT BID13004  
TO J. FLETCHER CREAMER & SON, INC. FOR  
SEWER COLLECTION SYSTEM MAINTENANCE AND REPAIR**

**WHEREAS**, the Sewer Division under the Department of Public Works provides for the maintenance and repairs to the municipal sewer system; and

**WHEREAS**, the two year agreement with the current vendor, J. Fletcher Creamer & Son Inc., to provide sewer collection system maintenance and repair is expiring; and

**WHEREAS**, Glenn Sandor, the Director for Department of Public Works, determined a need to continue having third party services available for sewer collection system maintenance and repair services; and

**WHEREAS**, on March 18, 2013 the Township Council of the Township of North Brunswick approved Resolution 108-3.13 authorizing the advertisement for receipt of bids for sewer collection system maintenance and repairs – BID13004; and

**WHEREAS**, the Deputy Municipal Clerk witnessed the receipt of two bids on April 11, 2013 and the lowest qualifying bid was submitted by J. Fletcher Creamer & Son, Inc.; and

**WHEREAS**, this bid is at an amount not to exceed \$124,390.00 for a two year term with the option for a one two-year extension; and

**WHEREAS**, funds in the amount of \$20,000.00 are available in account 3-07-55-502-000-183 and the balance shall be made available contingent upon funding within future budgets; and

**WHEREAS**, Ron Gordon with Decotiis, Fitzpatrick & Cole LLP, appointed Municipal Legal Counsel has reviewed the bid proposals and determined the bid submitted by J. Fletcher Creamer & Son, Inc the lowest responsible bidder under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

**NOW THEREFORE, BE IT RESOLVED**, that the bid of J. Fletcher Creamer & Son, Inc is hereby accepted.

**BE IT FURTHER RESOLVED**, the Township of North Brunswick does hereby authorize the Mayor to execute and Township Clerk to witness an agreement with J. Fletcher Creamer & Son, Inc for Sewer Collection System Maintenance and Repair BID13004 in an amount not to exceed \$124,390.00.
