

**A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK
AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH
AMIGO MEDICAL TRANSPORT
UNDER THE DEPARTMENT PARKS, RECREATION & COMMUNITY SERVICES
FOR
SENIOR TRANSPORTATION SERVICES**

WHEREAS, in September 2011 Senior Transportation Services contract CON11001 was authorized pursuant to resolution 257-9.11 with Amigo Medical Transport for a one year term with the option of two one-year renewals; and

WHEREAS, contract amendments increasing the authorized amount were included on resolutions 74-2.12 and 167-5.12; and

WHEREAS, in October of 2012 resolution 291-10.12 was passed authoring the Township to to extend the contract by one year with a revised term expiring September 30, 2013; and

WHEREAS, the current contract with Amigo Medical Transport has been successful and increased ridership among senior and disabled residents; and

WHEREAS, Director of Parks, Recreation and Community Services Lou Ann Benson has determined that due to an increase in ridership there is a need to increase the contract authorization from \$182,000 to \$252,000; and

WHEREAS, \$30,000 of the increased authorization totaling \$70,000 shall be funded from FY2013 Senior Operating Budget and the balance shall be funded contingent upon funding within the FY2014 budget; and

NOW, THEREFORE, BE IT RESOLVED on this 3rd day of June, 2013 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an amendment to the agreement with Amigo Medical Transport and increase the not-to-exceed amount from \$182,000 to \$252,000.


