

**A RESOLUTION AUTHORIZING AWARD OF CONTRACT BID15009
TO NATIONAL WATER MAIN CLEANING CO. FOR
MANHOLE REHABILITATION SERVICES**

WHEREAS, the Sewer Division under the Department of Public Works is responsible for providing maintenance and repairs of the municipal sanitary sewer system; and

WHEREAS, Eric Chaszar, the Director for Department of Public Works has determined it necessary to engage an outside company to provide manhole rehabilitation services; and

WHEREAS, the aggregate of the goods and services requested was anticipated to exceed the current bid threshold, and was therefore bid under a formal process pursuant to N.J.S.A. 40A:11-3; and

WHEREAS, on July 1, 2015 the Township Council of the Township of North Brunswick approved Resolution 186-6.15 authorizing advertisement and receipt of bids for Manhole Rehabilitation Project – BID15009; and

WHEREAS, the Deputy Municipal Clerk witnessed the receipt of three bids on June 25, 2015; and

WHEREAS, the lowest qualifying bid was submitted by National Water Main Cleaning Co. (1806 Newark Turnpike Kearney, NJ 07032) in the amount of \$8,250.00 for items 1 and 2; and

WHEREAS, compensation for manhole rehabilitation services shall be billed in accordance with the bid in an amount not to exceed \$5,000.00 for services ending June 30, 2016 and the balance of funds shall be certified upon the appropriation of funds in future fiscal years; and

WHEREAS, Township Attorney Ronald Gordon has reviewed the proposal submitted by National Water Main Cleaning Co. and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

WHEREAS, Eric Chaszar has reviewed and recommends to the Governing Body approval of the bid submitted by National Water Main Cleaning Co.

NOW THEREFORE, BE IT RESOLVED, that the bid submitted by National Water Main Cleaning Co. is hereby accepted.

BE IT FURTHER RESOLVED, Township of North Brunswick does hereby authorize the Mayor to execute and Township Clerk to witness an agreement with National Water Main Cleaning Co. (1806 Newark Turnpike Kearney, NJ 07032) for the manhole rehabilitation services in the amount of \$8,250.00 for a two year term August 1, 2015 – July 31, 2017.
