AUCTIONED ABANDONED MOTOR VEHICLES**




WHEREAS, notice of said auction was duly advertised in the Home News & Tribune on September 11, 2015; and


WHEREAS, bids were received September 25, 2015 and quotes were solicited after the auction for vehicles not bid on as per the attached list.


