

**A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK
AUTHORIZING A CHANGE IN SCOPE TO
THE PROFESSIONAL SERVICE AGREEMENT WITH
CME ASSOCIATES APPOINTED AS THE 2015
TOWNSHIP CONSULTING ENGINEERS TO INCLUDE
DESIGN SERVICES FOR
THE 2016 ROAD IMPROVEMENT PROGRAM**

WHEREAS, resolution 4-1.15 approved by the Township Council authorized CME Associates, of 3141 Bordentown Avenue, Parlin, NJ 08959, to provide engineering consulting services for calendar year 2015, as awarded under a fair and open contract process, pursuant to the provisions of N.J.S.A. 19:44A-20.1 et seq.; and

WHEREAS, CME Associates current agreement includes general engineering services to be provided to the Township as Consulting Engineers in an amount not to exceed \$100,000.00, 2014 Tax Map Maintenance and Update Services for a not to exceed amount of \$4,236.00, Route 130 Construction Phase Services for amount not to exceed amount of \$59,644.00, Construction Phase Services for the 2015 Road Program Project for an amount not to exceed \$254,858.00, Construction Phase Services for Nassau Street Improvements for a amount not to exceed amount of \$94,322.00, and Survey, Base Mapping and Design through Bid Phase Services for the How Lane Pump Station Improvements Project for a not to exceed amount of \$75,208.00 for a revised contract authorization totaling \$588,317.00; and

WHEREAS, the Department of Community Development is responsible for construction and improvements of various municipal streets, roads and curbing; and

WHEREAS, Michael C. Hritz, the Director of Community Development, has requested additional services of CME Associates to provide engineering services for the 2016 Road Improvements Program; and

WHEREAS, compensation for services shall be based upon the September 23, 2015 proposal submitted by CME Associates, to be paid upon submission of monthly invoices, for the phases as outlined below, at a proposed amount of \$398,484.00 for a revised contract authorization amount of \$986,801.00:



BE IT FURTHER RESOLVED notice of this action shall be published in the Home News & Tribune as required by law within 10 (ten) days after its passage






