

**A RESOLUTION OF THE TOWNSHIP OF NORTH BRUNSWICK  
AUTHORIZING THE AWARD OF CONTRACT BID15021  
TO DETACHABLE CONTAINER & COMPACTOR CORP.  
UNDER THE DEPARTMENT OF PUBLIC WORKS  
FOR ONE SIDE LOADING REFUSE PACKER**

**WHEREAS**, it was previously determined there is a need to replace one existing side loading refuse packer (2007 AutoCar - Vehicle No. 843) that has exceeded its useful life; and

**WHEREAS**, the Business Administrator has reviewed and approved the request by the Director for one roll-off truck; and

**WHEREAS**, funding for this item was included in the Fiscal Year 2016 Capital Budget; and

**WHEREAS**, on November 2, 2015 Resolution 285-11.15 authorized the advertisement for the receipt of bids for One Side Loading Refuse Packer – Bid15018; and

**WHEREAS**, due to substantial modifications to the Technical Specifications, BID15018 was cancelled; and

**WHEREAS**, on December 21, 2015 Resolution 317.12-15 confirmed the cancellation of BID15018 and authorized the re-advertisement for receipt of bids for One Side Loading Refuse Packer – BID15021; and

**WHEREAS**, the Deputy Clerk witnessed the receipt of two bids on January 14, 2016; and

**WHEREAS**, Detachable Container & Compactor Corp. (5039 Industrial Road, Farmingdale, NJ 07727) submitted the lowest bid in the amount of \$268,835.00 for One Side Loading Refuse Packer; and

**WHEREAS**, Eric Chaszar has reviewed the bid from Detachable Container & Compactor Corp. and determined their submission meets the specification requirements; and


**WHEREAS**, Ron Gordon with the firm Decotiis, Fitzpatrick & Cole LLP, appointed Municipal Legal Counsel, has reviewed the bid submitted by Detachable Container & Compactor Corp. and determined their bid both responsive and responsible under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.

**NOW THEREFORE, BE IT RESOLVED**, that the bid submitted by Detachable Container & Compactor Corp. in the amount of \$268,835.00 is hereby accepted.

**BE IT FURTHER RESOLVED**, on this 1<sup>st</sup> day of February, 2016, that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Detachable Container & Compactor Corp. for the purchase of one side loading refuse packer in the amount of \$268,835.00 pursuant to contract BID15021.
