

**A RESOLUTION OF THE TOWNSHIP COUNCIL OF NORTH BRUNSWICK
AMENDING THE ACCEPTANCE OF THE SALE OF
AUCTIONED ABANDONED MOTOR VEHICLES**

WHEREAS, on August 1, 2016 the Township adopted Resolution 216-8.16 authorizing the sale of municipally owned abandoned and/or unclaimed motor vehicles by public auction; and

WHEREAS, on August 4, 2016 notice of said auction was duly advertised in the Home News & Tribune; and

WHEREAS, bids were received August 19, 2016 and quotes were solicited after the auction for vehicles not bid on; and

WHEREAS, on September 6, 2016 Resolution 231-9.16 authorized the acceptance of the sale of municipally owned abandoned and/or unclaimed motor vehicles by public auction; and


WHEREAS, on September 22, 2016 the Township was notified by one of the successful bidder's (Mike's Auto) that he was rescinding his bid in the amount of \$500.00 for a 2003 Toyota Corolla and forfeiting his deposit in the amount of \$60.00; and


WHEREAS, on September 22, 2016 the Township solicited a quote for the vehicle and received a quote in the amount of \$100.00 from George Logan's Towing.





