

**A RESOLUTION AUTHORIZING THE AWARD OF CONTRACT BID16011
TO VITELLI TRUCKING, INC.
UNDER THE DEPARTMENT OF PUBLIC WORKS FOR
SNOW REMOVAL SERVICES**

WHEREAS, the Department of Public Works Street and Roads Division is responsible for providing snow removal services for public streets and access ways; and

WHEREAS, in addition to the Street and Roads Division providing in-house snow removal, the Department currently contracts out for supplemental services during large snow events; and

WHEREAS, the current three-year contract with Vitelli Trucking included a term from December 1, 2012 to November 30, 2015 and included the option for two additional one-year extensions; and

WHEREAS, pursuant to resolution 265-10.15 the current contract with Vitelli Trucking was amended to include a one-year extension with a revised expiration date of November 30, 2016; and

WHEREAS, Eric Chaszar, Director of the Department of Public Works, determined there is a continued need to have supplemental resources available due to the unpredictability of snow events; and

WHEREAS, on September 6, 2016 Resolution 238-9.16 authorized the advertisement for receipt of bids for Snow Removal Services – BID16011; and

WHEREAS, a bid opening was held on September 22, 2016 and one bid was received by the company White Bros. Concrete, with offices at 38 Brenwal Avenue, Ewing, New Jersey 08618, in the amount of \$2,170.00; and

WHEREAS, the bid submitted by White Bros. Concrete was reviewed and determined unresponsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

WHEREAS, the Director recommended to the Governing Body re-authorization of the advertisement for the receipt of bids for snow removal services; and

WHEREAS, on September 26, 2016 Resolution 259-9.16 authorized the re-advertisement for receipt of bids for Snow Removal Services – BID16011; and

WHEREAS, a bid opening was held on October 20, 2016 and one bid was received by Vitelli Trucking Inc. with offices at 617 Joyce Kilmer Ave., New Brunswick, NJ 08901 in the amount of \$320,600.00 for a two-year term; and

WHEREAS, Township Attorney Ronald Gordon has reviewed the bid submitted by Vitelli Trucking, Inc. and determined them responsive under the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey; and

WHEREAS, the two-year contract with Vitelli Trucking, Inc. shall commence on December 1, 2016 and end November 30, 2018 and includes an option for two (2) additional one-year terms.

NOW, THEREFORE BE IT RESOLVED, that the bid submitted by Vitelli Trucking, Inc. is hereby accepted.

BE IT FURTHER RESOLVED, on this 7th day of November 2016 that the Township Council of the Township of North Brunswick does hereby authorize the Mayor to execute and the Township Clerk to witness an agreement with Vitelli Trucking Inc. to provide Snow Removal Services pursuant to contract BID16011 with a not to exceed amount of \$320,600.00 with a two-year term December 1, 2016 – November 30, 2018.
